## Welcome to the 18th Annual Interior Plantscape Awards Program

The awards program is held each year to recognize excellence and professionalism in the interior plantscaping industry. Awards will be presented during CalScape Expo 2010 at the San Diego Sheraton Harbor & Marina in San Diego, CA on the evening of September 2, 2010.

Note that projects in the Design, Installation, Green Roof, and Major Renovation categories that have been completed during the past two years (June '08 to June '10) may be submitted. The time criterion for Atrium, Exterior Garden, Special Event & Holiday, Horticultural Service, Technician Recognition, and Silk, Replica, & Preserved is one year (June to June).

### ***A few pointers essential to the preparation of your entry:***

- **Read the Directions.** While you have the entry package in front of you, take a few minutes to read the directions. Make sure you understand everything that will be required. **An incomplete or garbled entry could cause your project to be disqualified** before the judges have a chance to see it. **Note: Do not identify or name your company in the photos or description.** This will immediately disqualify the entry.
- **Take Quality Photos.** Plan ahead and take quality photos. While preferred, it is not essential that your project be professionally photographed. If you are not comfortable with a camera, ask a friend who is, or you might contact the photography department at a local school or college for help in finding someone to assist you. Good quality photos are one of the keys to a winning entry. Allow enough time to retake any shots that did not come out the way you want your project to be viewed. With each entry you are required to submit 1) one digital file for each photo in **tif or jpeg format** and 2) **ONLY** two 4" x 6" prints of the photograph you would like used on the awards plaque, should you receive an award.
- **Describe the Project, Not the Photos.** When you are filling out the project description sheet, describe the project, not the photos. Choose photos that complement your descriptions of the project. Use only the space provided on the form. **The description page is 10 point font and 1 page only.** Also, keep your description relevant to your category. Describe the design for a design entry, installation challenges for an installation entry, etc. Each photo must be **NUMBERED 1-10** and be accompanied by a written description, or that image will be eliminated from the judging. **When you print your description page, make sure it is all on one page.**
- **Type Your Entry.** The judges will be reading your descriptions so take time to make the wording clear and concise. **Make your description a commentary that focuses on the criteria of the category.** Please save the entry form and project descriptions electronically onto the same CD with your digital images.

The deadline for postmarked entries is 5pm on June 9, 2010. Late entries with a postmark of up to 5 pm on Monday, June 14, 2010 will be accepted and must include the \$26 late fee per entry. # 2010 PIA INTERIOR PLANTSCAPE AWARDS PROGRAM RULES

The PIA Awards Program is open to all individuals and/or firms actively involved in the interior plantscape industry. You need not be a PIA member to enter. It is designed to recognize excellence and professionalism. Awards will be presented to the winning entries at the 18th Annual PIA Interior Plantscape Hall of Fame and Awards Banquet during CalScape Expo 2010 on September 2, 2010.

## GENERAL POLICIES AND PROCEDURES

1. Categories are: Design, Installation, Major Renovation, Special Event, Exterior Garden, Green Roof, Atrium, Silk, Replica & Preserved, Horticultural Service, (all of which have six dollar-value sub-categories); and Technician Recognition. The same project may be entered in as many categories as appropriate. Projects that have previously received a PIA Award may not be re-entered in the same category. Note that projects in the Design, Installation, Major Renovation, and Green Roof categories that have been completed during the past two years (June '08 to June '10) may be submitted. The time criterion for Special Event & Holiday, Exterior Garden, Atrium, Silk, Replica & Preserved, Horticultural Service, and Technician Recognition is one year (June to June).
2. Entries will be judged by photos and project descriptions. Each entry must be in the form of a completed Official Entry Form and Project Description, using only the space provided. Accompanying these must be a minimum of five (5) and a maximum of ten (10) digital files in tif or jpeg format for each photo as well as two 4" x 6" color prints of the picture you would like to see on the plaque should your project win an award. The digital files must be at a resolution of at least 300 dpi and print at size 4" x 6". Videocassettes or other forms of photographic reproductions will not be accepted. All fees (including late fee if applicable) must be included with Official Entry Form and Project Descriptions. Any entry received without payment may be disqualified. Please save your entry form and project descriptions electronically onto the same CD with your numbered digital images.
3. Digital images must be labeled with the project name and **numbered** in the order you wish the judges to view them. DO NOT identify yourself or your company in the pictures or your description. Company identification will result in immediate disqualification of the project. If the same project is entered in more than one category, separate sets of photos and a digital image file of each print at 300 dpi formatted to 4"x6" print size are **required** for each entry.
4. All entries must be postmarked by June 9, 2010. Late entries will be accepted with an additional fee if postmarked up until 5pm on June 14, 2010. The entry fee must accompany the entry and there will be no refunds. All entry materials become the property of PIA, and entry prints, files, and forms will not be returned. Make duplicates of prints and files before submitting your entry if you think you will have future need for them. PIA has the right to publish all entries and entry forms in PIA publications and on the PIA website, and to use them in promotional materials for PIA and CalScape Expo and in other publications promoting the interiorscape industry.
5. Judges will consist of a panel of three plantscape industry professionals. Identity of the judges will be released after the judging has occurred. The judges will not know the identity of entrants until after the judging is completed.
6. Award of Excellence and Award of Merit awards will be given. **Entries are not judged against each other.** Points are awarded based on the entry description information and pictures submitted. An **Award of Excellence** is achieved by earning 90%+ of the total number of points possible. An **Award of Merit** is achieved with 80-89% of the total number of points possible. If one project is considered by the judges to have merit considerably greater than that of any other project, they may choose to bestow a special **Judges Award** on that project. A Judges Award may be given to only one project in a year in the entire awards competition.

Projects in this category will be judged on their overall plant design characteristics and enhancements of the environment. Special attention will be paid to form, shape, texture, color, scale, proportion, creativity, originality, container selection and special features. Further consideration will be given to horticultural aspects such as light, temperature, and maintenance requirements. Design projects submitted must have been designed by the entrant company within the last 2 years. Dollar values in this category represent the total retail sales price for materials installed, including tax and labor.	<ol style="list-style-type: none"> <li>1. ## INSTALLATION

Projects in this category will be judged on the quality and complexity of the installation. Special consideration will be given to the use of sub-irrigation, proper staging materials, safety precautions, problem solving, special handling or equipment required, and planning for ongoing care and maintenance. Projects need not have been designed by the installing entrant, but must have been installed during the past two years. Dollar values in this category represent total retail sales price for materials installed, including tax and labor.	<ol style="list-style-type: none"> <li>1. ## HORTICULTURAL SERVICE

Projects in this category will be judged on the overall appearance, including plant health, cleanliness of the foliage and containers, care of top dressing, appropriate pruning and trimming, and pest control. Special consideration will be given to unique maintenance requirements (e.g. color rotations) and maintenance of special features (e.g. replicas, water features, rock). ## MAJOR RENOVATION

Projects in this category will be judged on the quality and type of materials used, but primarily on the improvement of the plantscape affected by the renovation. Special attention will be paid to enhancements such as use of sub-irrigation, new containers, new ground coverings or top dressings, etc. At least one-half of the existing plantscape must have undergone renovation during the past two years to be considered for this category. Two to three "before renovation" and seven to eight "after renovation" photos are required. light, and texture. This category includes short-term interior plantscapes such as seasonal displays or exhibits and event rentals. The event must have occurred during the past year (June to June). Dollar values in this category represent the total retail sales price for materials installed, including tax and labor.

### TECHNICIAN RECOGNITION

Specific Category Guidelines	Judging Criteria
<p>In addition to the criteria in the horticultural service category, technicians will be judged on their contribution to the entrant company and the horticultural community. Consideration will be given to pesticide licensing, certification, on the job safety, timely replacements, client satisfaction, and PIA involvement. An entry in this category must include a project that has been maintained by that same technician for at least one year, and that individual must be at least 75% responsible for the project. Only one photo of the technician should be included with supporting photos of the project he/she maintains. In addition to the Official Technician Entry Form and Project Description Form, with each entry you are required to submit 1) one digital file for each photo and 2) two 4" x 6" prints of the photograph you would like used on the awards plaque should you receive an award. <p>Projects in this category will be judged on the quality and complexity of the installation. An Atrium is a glass enclosed space designed to specifically mimic an outdoor environment under glass. Special consideration will be given to the use of sub-irrigation, proper staging materials, safety precautions, problem solving, special handling or equipment requirements, and planning for ongoing care and maintenance. Atrium projects submitted must have been installed by the entrant company since last June. Green Roof projects have a separate set of project criteria. Exterior Garden projects will be judged on their overall characteristics and enhancements of the environment. Special attention will be paid to form, shape, texture, color, scale, proportion, creativity, originality, container selection, special features, adherence to construction standards, and irrigation efficiency. Further consideration will be given to horticultural aspects such as light, temperature, and maintenance requirements. Projects in this category must have been installed by the entrant company since last June. Green roofs are engineered light-weight roofing systems covered with vegetation growing in media planted over a water proof membrane on a man made structure ( not planters). They will be judged on the quality and complexity of the project. Special consideration will be given to the use of irrigation, plant material not requiring irrigation, safety precautions, problem solving, special handling or equipment required, and planning for ongoing care and maintenance. Projects need not have been designed by the entrant but must have been installed during the past two years. Special attention will be paid to form, shape, texture, color, scale, proportion, creativity, originality, container selection and staging, as well as safety issues, special needs, as well as, degree of difficulty for installation or client requirements. Silk, Preserved and Replica design/ installation projects must have been installed by the entrant company since last June and be composed of at least 80% silk, preserved, and/or replica materials. ## LIVING WALL

Specific Category Guidelines	Judging Criteria												
<p>Living Walls are self sufficient vertical gardens that are attached to the exterior or interior of a building. They differ from green facades (e.g. ivy walls) in that the plants root in a structural support, which is fasted to the wall itself. The plants receive water and nutrients from within the vertical support instead of from the ground. Living Walls will be judged on the quality and complexity of the project. Special consideration will be given to the use of irrigation, plant material, drainage, safety precautions, problem solving, special handling or equipment required, and planning for ongoing care and maintenance. Projects need not have been designed by the entrant but must have been installed during the last two years.</p>	<table> <tr><td>1.
